Summer 2019 FLAS

Eligibility Requirements: *Undergraduate Students*

- Must be a full-time student
- U.S. citizen or permanent resident
- Must have completed the equivalent of two semesters of language study by May 2019

Eligibility Requirements: *Graduate/Professional Students*

- Must be a full-time student
- U.S. citizen or permanent resident
- May be at the beginning, intermediate, or advanced level of the language they wish to study

Program Details

- Tuition and partial fee support up to \$5,000
- Living stipend of \$2,500
- Eligible Languages include: Quechua, Portuguese, or other Latin American language (not including Spanish)
- Eligible Summer programs include those offered at Ohio State, other domestic universities, or overseas.
- Beginning and intermediate language programs must provide 140 classroom hours (7 weeks minimum).
- Advanced programs must provide 120 classroom hours (or 6 weeks minimum).

Academic Year 2019-2020 FLAS

Eligibility Requirements: *Undergraduate Students*

- Must be a full-time student
- U.S. citizen or permanent resident
- Must have completed the equivalent of two semesters of language study by August 2019

Eligibility Requirements: *Graduate/Professional Students*

- Must be a full-time student
- U.S. citizen or permanent resident
- May be at the beginning, intermediate, or advanced level of the language they wish to study

**Tuition & Stipend Support:
Undergraduate Students**

- Tuition and partial fee support up to \$10,000
- Living stipend of \$5,000
- Students may not hold concurrent employment on campus during the Fellowship year

**Tuition & Stipend Support:
Graduate/Professional Students**

- Tuition and partial fee support up to \$18,000
- Living stipend of \$15,000
- Students may not hold concurrent employment on campus during the Fellowship year

Program Details

- Eligible Languages include: Quechua and Portuguese. Other Latin American languages (not including Spanish) may be available with prior approval from the Center for Latin American Studies.
- All students must take one classroom-taught language course each semester and one area studies course each semester.

How do I become eligible for an Academic Year 2019-2020 FLAS if I'm not already enrolled in a language?

- Undergraduate students interested in applying for an Academic Year FLAS for Quechua may enroll in Quechua 5501 in Spring 2019 and Quechua 5502 in Summer 2019. This will allow students to meet the language eligibility requirement.
 - The Spring 2019 and Summer 2019 sections of these courses are online and therefore easy to schedule, but students also have face-to-face access to the instructor at OSU. Graduate and professional students may also enroll.
 - Quechua classes in Autumn 2019 will be via classroom delivery, not online, in order to be FLAS-eligible.
